

CONTEST REGULATIONS

1. This contest is held by Éconofitness to mark its 10th anniversary. On December 1st, 2023, Éconofitness will draw 10 travel credits in the amount of \$1,500 each among all Éconofitness members in good standing with an active membership who have completed the entry form, including a mathematical skill-testing question, <https://info.econofitness.ca/10-years-contest>. The online promotion of this contest will begin on Monday, August 28. The contest will also be announced at Éconofitness's 10th-anniversary party on Thursday, September 7, 2023, at 6:00 p.m. (EDT).

ELIGIBILITY

2. All Éconofitness members in good standing who have an active membership as of December 1st, 2023, and who have completed the entry form, including a mathematical skill-testing question, at <https://info.econofitness.ca/10-years-contest> will be eligible to enter the contest. A member in good standing is a member who: (i) has not violated any of the rules of conduct set out in the Éconofitness Code of Conduct (available in all Éconofitness gyms), (ii) has no overdue payments, and (iii) has an active membership as of December 1, 2023. To enter the contest, in addition to having reached the age of 18, eligible Éconofitness members must be residents of Quebec. Employees of Éconofitness, their subsidiaries, affiliates, representatives, agents or successors of advertising agencies and persons with whom they are domiciled (regardless of relationship) are not eligible to enter the contest.

HOW TO PARTICIPATE

3. The contest is open to all Éconofitness members in good standing with an active membership as of December 1, 2023. To enter the contest, in addition to having reached the age of 18, eligible Éconofitness members must be residents of Quebec. **Members in good standing wishing to enter the contest must complete the entry form, and answer a mathematical skill-testing question, at <https://info.econofitness.ca/10-years-contest>.** One entry per member in good standing. A member in good standing is a member who: (i) has not violated any of the rules of conduct set out in the Éconofitness Code of Conduct (available at all Éconofitness gyms), (ii) has not made any late payments, and (iii) has an active membership as of December 1, 2023. The member who meets all these criteria will have one (1) chance to participate.

THE DRAW

4. The draw will take place on Monday, December 4, 2023, at 1:00 p.m., at Éconofitness head office, 1040 Michèle-Bohec Boulevard, Suite 300, Blainville, QC, J7C 5E2. Each member in good standing who completes the entry form and answers the mathematical skill-testing question will be assigned a number. Ten (10) numbers will then be drawn at random. Member profiles corresponding to the numbers drawn will first be verified to ensure that each winning member is a member in good standing with an active membership.

THE PRICE

5. 10 winners will be drawn at random. Each winner will receive one (1) \$1,500 travel credit.
 - The prize will be given in the form of a certificate.
 - **Substitution: instead of receiving a \$1,500 travel credit, the winner can choose to receive a \$1,500 cheque.**
 - The total value of the prizes for this contest is 10 X \$1,500 = \$15,000.

CHANCES TO WIN

6. The odds of winning prizes depend on the number of Éconofitness members in good standing with an active membership as of December 1, 2023, who complete the entry form at <https://info.econofitness.ca/10-years-contest>.

All winners will be announced at <https://econofitness.ca/en/contests-winners>. Éconofitness or its designated representative will make at least two (2) attempts to contact the winning members. Winners will have 72 business hours to respond, failing which the contest will be void. If the winner does not claim the prize within 72 business hours of communication, an alternate name will be randomly selected from the remaining eligible entries. If the winner does not meet all the conditions set out in these Contest Rules, or if the winner refuses to accept
